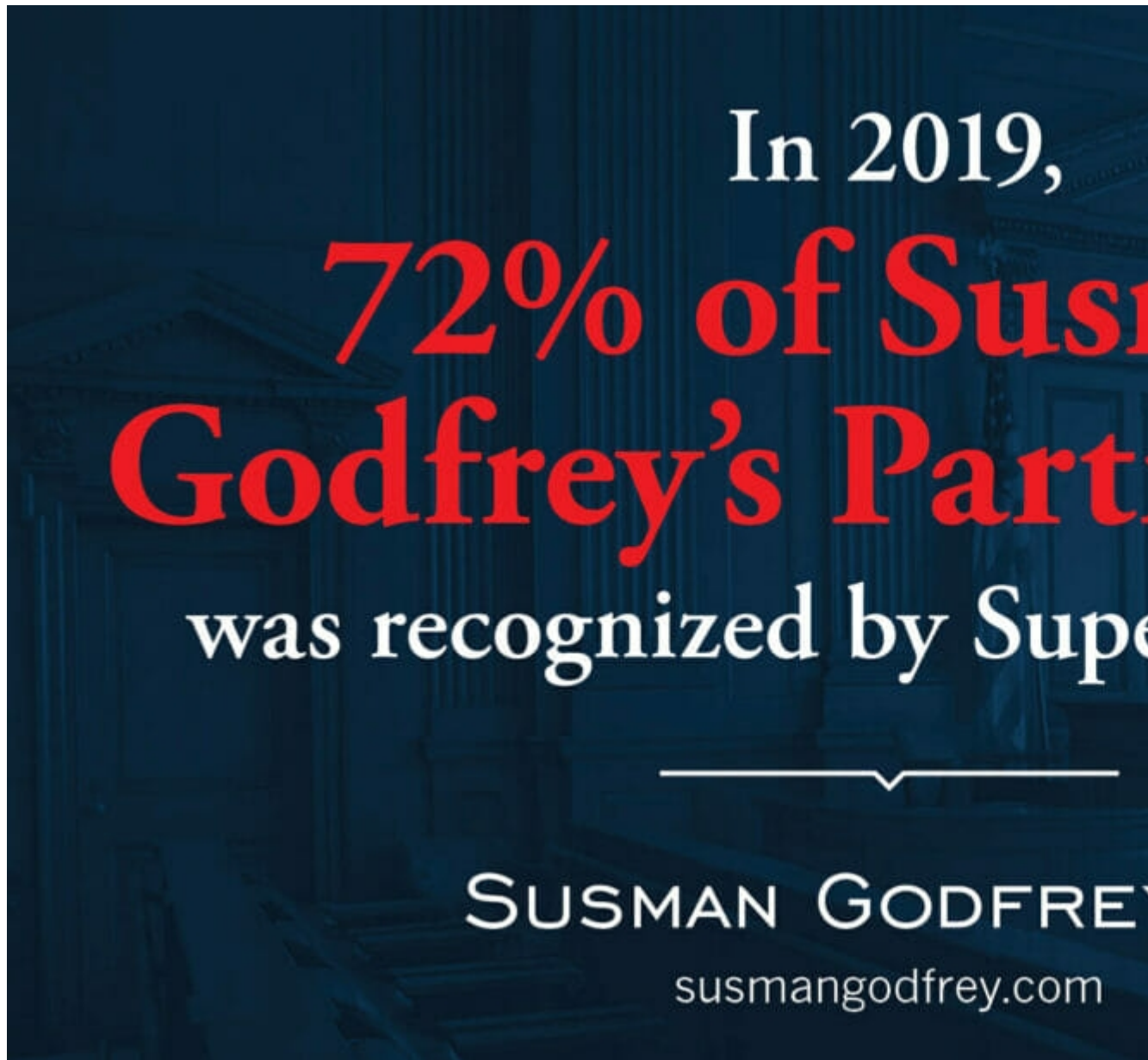


## Super Lawyers Honors Susman Godfrey Attorneys 2019

In 2019, Weston O'Black, Shawn Rabin, Stephen Shackelford, and Genevieve Wallace were named Super Lawyers in their respective states for the first time, and John Schiltz was named a Rising Star for the first year in Washington state.

The selection process for the Rising Stars list is the same as the Super Lawyers selection process, with one exception: to be eligible for inclusion in Rising Stars, a candidate must be either 40 years old or younger or in practice for 10 years or less. No more than 2.5% of the top attorneys in a selected area are named to the Rising Stars list. *Super Lawyers* is published by Thomson Reuters.
